Bridging Social Capital

Milestone 里程碑

- 2006 The Hong Kong Council of Social Service (HKCSS) set up the **Social Enterprise Resources Centre**, produced the first **Social Enterprise Directory** in Hong Kong and organized a series of training courses and activities.
- Submitted a proposal on advancing social enterprise to the Commission on Poverty.
- 香港社會服務聯會(社聯)成立「**社會企業資源中心**」，製作全港首本《**社企指南**》及舉辦多項課程與活動。
- 向扶貧委員會提交建議書，倡議政府大力支持社會企業。

- 2007 Proposed to the Chief Executive on enhancing policy support to social enterprise. The Chief Executive incorporated "Social Enterprise" as one of the major initiatives of his Policy Agenda.
- Joined hands with Wanchai District Council to organize the first "**Social Enterprise Marketplace**" in pedestrian zone of Causeway Bay. Over 40 social enterprises participated in the event.

- 向特首建議加強支援社企的政策。其後特首將「社會企業」列為主要施政綱領。
- 與灣仔區議會合作，在銅鑼灣行人專用區舉辦首個「**社會企業展銷日**」，展銷40多間社企的產品。

- 2008 Jointly funded by the Hongkong Bank Foundation and the Partnership Fund for the Disadvantaged, the **HKCSS - HSBC Social Enterprise Business Centre** was launched.
- Co-organized the first **Social Enterprise Summit** with other SE partners.
- Launched various services such as "**Social Angels Programme**" and "**SE Incubation Scheme**".

- Facilitated the set up of the **Hong Kong General Chamber of Social Enterprises** and served as the Secretariat at the Chamber's start up stage.

- Successfully incubated "**Happy Veggies**" and helped a number of organizations in applying SE start-up grants.
- Started up **ACT Social Awareness Network** to organize social experiential learning activities for raising awareness of SE's value and social issues.
